We are so grateful for your gift of 31 blankets, 90 pairs of men's socks, 84 pairs of women's socks, and 30 pairs of children's socks, and 16 pairs of children's gloves received by Interfaith Community Services on 12/9/2009. We appreciate your membership in the Interfaith family of donors! -- and we need your ongoing help. With your help, Interfaith is able to help serve the needs of friends and neighbors in North County who find themselves in despair because of extreme need.

Daily more than 80 individuals and families arrive at our doors in Escondido and Oceanside seeking help. The most common requests are for shelter, food, and assistance with prescriptions. Interfaith's employment labs, helping unemployed and underemployed individuals to find jobs, are overflowing.

We have seen an enormous increase in the number of families and individuals requesting emergency services over the past two years. The sharpest increase -- up 85% -- is in two-parent families who are simply unable to make ends meet. Homelessness, particularly among families, is on the rise.

We are hoping for a brighter future, and we thank you for finding it in your heart to assist others in need! Thank you for coming forward to help.
