Thank you for your gift of 28 turkeys and 40 cases of food given by David and Kathy and received by Interfaith Community Services on 11/17/2009. Interfaith is working hard to serve the needs of our North County friends and neighbors who find themselves in extreme need.

We have seen an enormous increase in the number of families and individuals requesting emergency services over the past two years. The sharpest increase -- up 85% -- is in 2-parent families who are simply unable to make ends meet. Homelessness, particularly among families, is on the rise.

Daily more than 80 individuals and families arrive at our doors in Escondido and Oceanside seeking help. The most common requests are for shelter, food, and assistance with prescriptions. Interfaith's employment labs, helping unemployed and underemployed individuals to find jobs, are overflowing.

In an unstable economy that has not yet turned around, we are so grateful that you found it in your heart to assist others in need! Thank you for coming forward to help.
